### DEFINITION OF A RESIDENT FOR SINGAPORE TAX PURPOSES

A resident for the purposes of Income Tax Act, is defined in the following terms :

“In relation to an individual, means a person who, in the year preceding the year of assessment, resides in Singapore except for such temporary absences therefrom as may be reasonable and not inconsistent with a claim by such person to be resident in Singapore, and includes a person who is physically present or who exercised an employment (other than as a director of a Company) in Singapore for 183 days or more during the year preceding the year of assessment.

In relation to company or body of persons, means a company or body of persons the control and management of whose business is exercised in Singapore.”
