- (a) By completing this Prudential Visa/MasterCard (“PruCard”) Regular Premium Payment Application Form you are instructing Prudential and authorising Standard Chartered Bank to automatically debit your PruCard account to pay for your and/or your Family Members’ life assurance premium(s) as indicated overleaf. “Family Members” shall mean your spouse, children, parents, parents-in-law, brothers and sisters as indicated overleaf.
  - (b) Premium payments with the use of PruCard shall apply only to regular premium proposals/policies. Please note that PruCard may not be used for payments of premiums for Single Premium Policies, Recurring Single Premium policies, Top-up premiums and policies purchased under the CPF Investment Scheme and Supplementary Retirement Scheme.
  - (c) Please continue to pay by cash, cheque or Giro for all premium(s) until your PruCard Regular Premium Payment Application is approved.
  - (d) Upon approval of your PruCard Regular Premium Payment Application, the premium(s) amount will be charged to your PruCard on the due date of the premium(s) and your credit card statement will show the proposal/policy number(s) and the amounts charged.
  - (e) Regular premiums that are charged to your PruCard exceeding its credit limit available at the time of debit will be rejected. Please ensure that your credit limit is sufficient for these payments.
  - (f) You hereby authorise Standard Chartered Bank to notify Prudential of any changes in your PruCard account details. In the event that any new PruCard account (each, a “New PruCard Account”) is issued to you in addition to and/as replacement or in lieu of this PruCard account as indicated, these terms and conditions shall be deemed to apply to each such New PruCard Account. For avoidance of doubt, you hereby irrevocably authorise Standard Chartered Bank and Prudential to debit each New PruCard Account for the payment of all permitted regular premiums in relation to the proposals/policies indicated herein. This authorisation shall be in addition to any other consent and/or disclosure that you may have provided to Standard Chartered Bank.
  - (g) All authorisations referred to above shall remain in force until terminated by you in accordance with this clause.
